

## **Organ Donation Promotion Campaign**

### **Invitation to Sign the Organ Donation Promotion Charter**

For patients suffering from end-stage organ failure, organ transplant is their hope for gaining a new life. Organ donation and transplant, and eventually whether patients can be saved, depend on a number of factors. However, one of the most important factors is the attitude of the general public towards organ donation. It is more regretful that many patients would die before the right organ match comes. To shorten patients' waiting time for organ transplant and to bring new life, active support for organ donation by members of the public is critically important. Therefore, the Government has been working to inculcate a culture of organ donation in the community, aiming to reduce individuals' and family members' resistance and hesitation to organ donation.

The Department of Health (DH) launched the Centralised Organ Donation Register (CODR) ([www.codr.gov.hk](http://www.codr.gov.hk)) in 2008, providing a platform for the public to register their wish to donate organs. As at June 2022, more than 340 000 registrations were recorded in the CODR.

The Government has set up the Committee on Promotion of Organ Donation ("the Committee") in April 2016 to further promote organ donation to co-ordinate and integrate the work by different government departments and organisations on organ donation, so as to amplify the promotional effect. The Committee is responsible for implementing the Organ Donation Promotion Campaign, which includes formulation of organ donation promotion strategy and direction, coordination and collaboration with other partners in conducting organ donation promotional activities and programmes and conducting public education.

The Committee are now inviting organisations/companies to join us as partners in the Organ Donation Promotion Campaign by signing the Organ Donation Promotion Charter at the (**Annex 1**) to this letter and signify your support towards the promotional activities on organ donation. The Committee would also like to invite you to share with them your implementation plan (**Annex 2**). Your effort and contribution will be publicised in the Organ Donation website of the DH.
